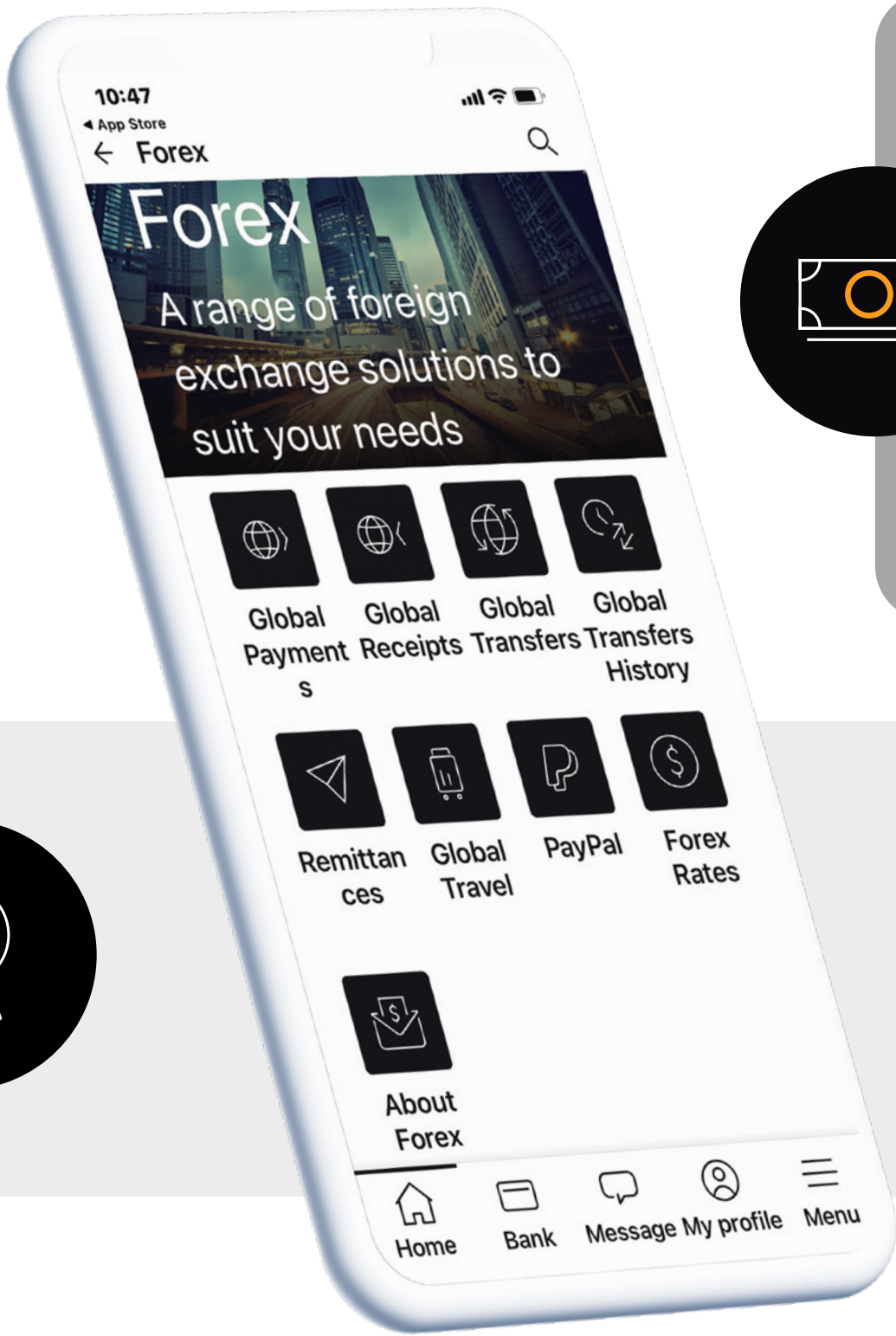

The standard withdrawal rate on all Top-up and withdraw transactions is 1.52%. However, you can withdraw for as little as 0.81%, depending on your previous month’s transactional value.

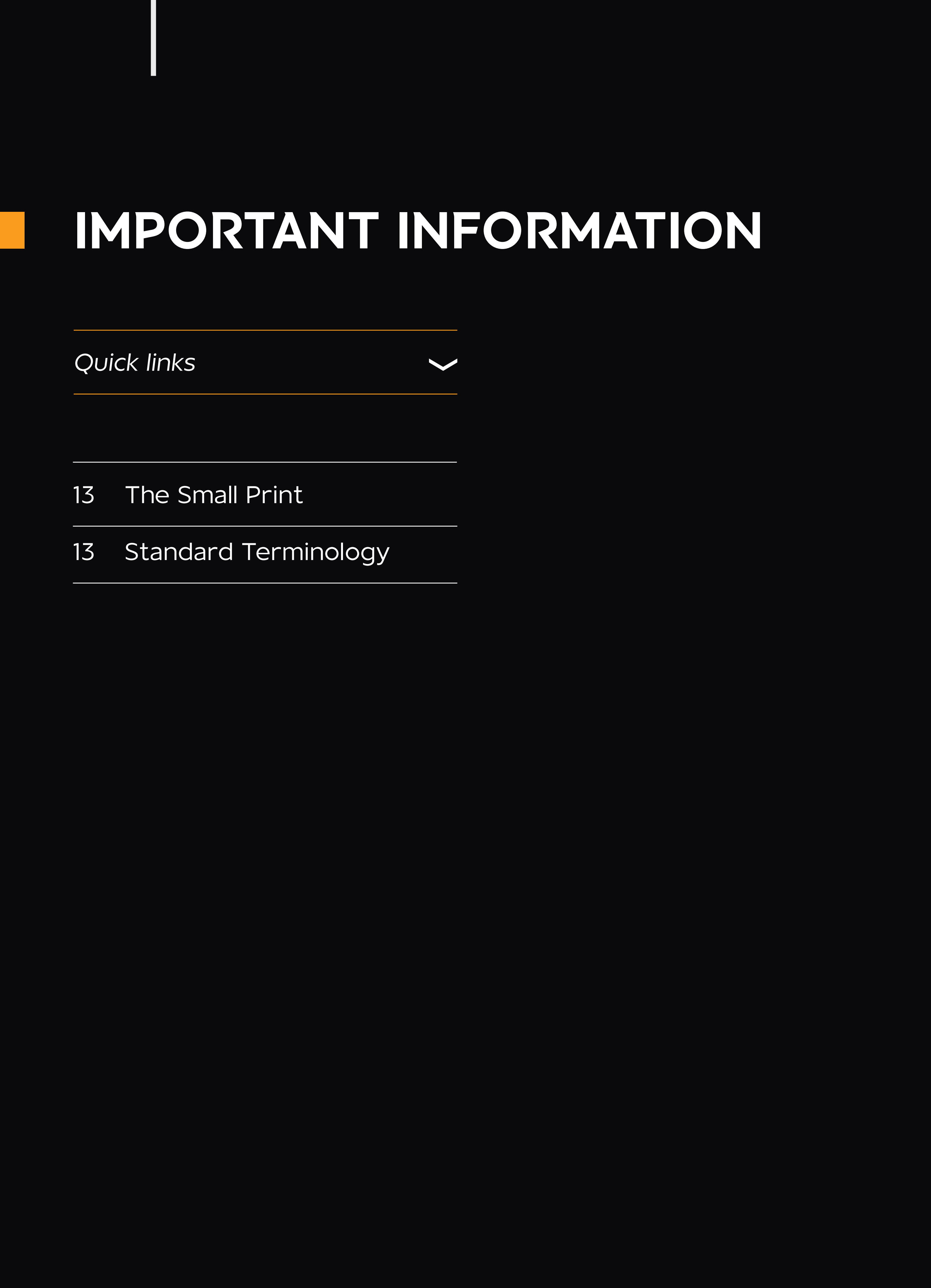
