Entries open and close:	<p>Entries open on Tuesday, 1 July 2025 at 00:00.</p> <p>Entries close on Tuesday, 30 September 2025 at 00:00.</p> <p>All entries, fully completed as required, must be received by the promoter(s) before (time) on the closing date.</p> <p>The promoter(s) reserve the right to extend the competition. Notice of this will be posted in these rules.</p>
What is the prize?	A share of R200 000 (two hundred thousand rand) towards any RMB investment account of your choice.
Winner/s announced on:	28 November 2025
Eligibility: Who qualifies to take part?	This competition is open to all individuals over the age of 18 who live in the Republic of South Africa.

	<p><i>that none or your RMB Private Bank/FNB and FirstRand Bank accounts and credit agreements should be overdrawn, or be in arrears, or be in default, or be subject to any legal process with RMB Private Bank/FNB or FirstRand Bank. Is there a limit on the number of times you can enter?	<p>There is no limit to the number of times one can enter. Multiple entries are allowed.</p>
How will winner(s) be chosen?	<ol style="list-style-type: none"> 1. Winners will be chosen randomly using an electronically generated draw process. 2. The final draw will take place by 28 November 2025. 3. Contacted winners will need to confirm that they accept their winning for the promoter to pay out the winnings.

General Rules

IMPORTANT – PRIVACY MATTERS

Participants in this competition understand and agree that for us to offer this competition, we may collect and use personal information about participants. This personal information may include your first name, last name, email address, mobile number, ID number and in certain instances your [image](#). IMPORTANT – LIABILITY

You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the competition rules. This means you agree to reimburse the promoter(s) for the following: any loss or damage they suffer, any expenses and costs they paid or are responsible for. Legal costs mean costs on an attorney and own client scale.
