COMPETITION RULES

Read these Competition rules carefully. These Competition rules ("rules") explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules.

Competition Name:	WIN eB1 000 000!
Promoter(s) Name(s):	This Competition is run by FNB-eBucks Rewards, a business unit within FirstRand Bank ("FNB") Limited (Registration Number. 1929/001225/06) ("eBucks") having its principal place of business at 10th Floor, FNB Place, Bank City, Cnr Kerk and Diagonal Street, Johannesburg Gauteng, South Africa, 2000. The person responsible for conducting the promotional Competition on behalf of eBucks is Dimakatso Mataruka, a Merchandise Planner. In these rules we refer to the above promoter(s) as "the promoter(s)", or "us" or "we". We will refer to participants and winners as "you".
The prizes	<ul style="list-style-type: none">• The Competition runs for 4 weeks with one winner that will be announced at the end of the Competition period.• The winner will receive eB1 000 000 (one million eBucks) (with an equivalent Rand value of R100 000 (one hundred thousand Rand)).• The prize will be deposited into the prize winner's eBucks account.• The prize is not redeemable for cash and is not transferable to any person other than the drawn winner.• Participants must have a minimum spend of R2500 (two thousand five hundred Rand), eB25 000 (twenty-five thousand eBucks) or a combination spend of Rand and eBucks that adds up to R2500 or eB25 000.• Each individual order (regardless of the number of items in the order or the maximum value of the order) counts as one entry.
Entries open:	Entries open on 8 March 2018 at 8:00am
Entries close:	Entries close on 31 March 2018 at 11:59:59 pm. All entries must be received by us before 11:59:59 pm on 31 March 2018. The promoter(s) reserve the right to extend the Competition by amending these Competition rules.
Is there a limit on the number of times you can enter?	There is no limit on the number of entries. Every separate purchase of one or more products from the "Apple" category on the eBucks Shop to the value of at least eB25 000 (R2 500) will count as one entry into the draw.
Winner announced on:	The winner will be announced on 12 April 2018.
Eligibility: Who qualifies to take part?	This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is a member of the eBucks Rewards Programme, as well as legal entities duly incorporated in accordance with the relevant laws of the Republic of South Africa, excluding the categories of people listed below who cannot take part. By entering this Competition, participants warrant that they do not fall into any of the below mentioned excluded categories of people.
Who cannot take part?	The following persons may not take part in this Competition, will be disqualified if they do and will forfeit any prizes that may have been awarded to them:

How to enter?	<p>There are no entry fees. To enter, Participants must (between 1 March 2018 and 31 March 2018), purchase one or more products from the "Apple " category in the eBucks Shop to the value of at least eB25 000 or R2 500. If however you return the product(s) purchased before the draw date, your entry will be invalid and will be withdrawn from the Competition.</p> <p>By purchasing the product(s) as described above you will automatically be entered into the Competition. eBucks is not responsible for any lost, corrupted or delayed entries and these will be deemed invalid. Entries must be received by eBucks after the Competition opening time and no later than the Competition closing time. Each entry constitutes full and unconditional acceptance of these Rules. eBucks reserves the right to disqualify anyone in breach of these Rules. No telephonic, faxed, emailed or posted entries will be accepted.</p>
How will winner(s) be chosen?	<p>A random draw will take place on 5 April 2018 to determine the winner. The random entry drawn will be checked to establish whether it meets the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk & Compliance team. The winner will be drawn from the transactional sales data for the Competition period. Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the eBucks Website within four days of the original draw date. The random entry drawn will be checked to establish whether it meets the Competition qualifying criteria and if so that entry will be the prize winner, subject to us being able to contact such winner within 48 (forty-eight) hours of the draw taking place. If the qualifying criteria to enter the Competition are not met, a further random draw will take place until a randomly selected, valid entry meets the eligibility criteria.</p>
How will winner(s) names be announced?	<p>The winner will be notified within 48 hours of the draw taking place via email by the eBucks Corporate Communications team, to the contact details recorded on the winner's eBucks account. Unless you instruct us to the contrary within 24 hours of being notified that you have won a prize, you consent to your name, image and prize being announced on FNB's Facebook and Twitter pages and on the eBucks.com website. Deadline for claiming prize(s)	<p>If a potential winner cannot be reached by us within 48 hours, through no fault of ours, the prize will be forfeited by that potential winner and will be awarded to the next eligible winner assessed as aforesaid.</p>
Data Usage and Privacy Policy	<p>Participants in the Competition understand and agree that in order to offer the Competition, we may collect and use personal information about participants. This personal information may include a participant's first name, last name, email address, mobile number and in certain instances your image. Personal data, which participants provide when they enter the Competition, may, subject to prevailing law, be used for future eBucks marketing activity, unless you notify eBucks that you wish to opt out of receiving such marketing communications. We will treat your information in total confidence and will not sell, share or rent this information to any other third parties. We may disclose information if required to do so by law or if it is required to protect the safety, rights or property of eBucks, our members, customers or the public.</p>
General	<p>No correspondence will be entered into regarding either this Competition or these Rules. In the unlikely event of a dispute, our decision shall be final. We reserve the right to amend, modify, cancel or withdraw any aspect of this Competition in our sole discretion at any time without notice or liability. We cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Competition agree that we will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a prize, or from participation in this Competition. The laws of the Republic of South Africa govern this Competition. If any provision or part of these Rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder</p>

	of these Rules shall remain in force. Any violation of these Rules will result in the immediate disqualification of the transgressing participant from the Competition.

IMPORTANT

- You agree to indemnify the promoters fully for any loss or damage the promoters may suffer because you breached the Competition rules. GENERAL RULES

or all of its rights at a later stage. You must not assume that this means that the rules have been changed or that it no longer applies to you.
