Read these campaign rules, terms, and conditions carefully. These campaign rules, terms, and conditions ("Rules") explain Your rights and duties in connection with this campaign. 	All entries, fully completed as required, must be received by the promoter(s) on or before (time) the closing date.

	6. Must pay with their RMB Private Bank Card (Physical or Virtual card)

General Rules

IMPORTANT - PRIVACY MATTERS

IMPORTANT - LIABILITY

You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the competition rules.
