	All entries, fully completed as required, must be received by the promoter(s) before 23:59 pm on the closing date.
	The promoter(s) reserves the right to extend the competition. Notice of this will be posted in these rules.
Winner's announced on:	The prize winners will be notified of their winnings within a period of seven (7) working days from the date of the draw. Winners will be announced on 30 April 2026.
