



COMPETITION RULES

Read these competition rules carefully. These competition rules (“rules”) explain your rights and duties under this competition. Promoter(s) Name(s):	This promoter of this competition is FNB Private Core Banking, a business unit of FNB, a division of FirstRand Bank Limited with Reg. No. 1929/001225/06 (“FNB”). In these rules we refer to the above promoter(s) as “the promoter(s)” or “FNB”. We refer to participants and winners as “you”.
Entries open and close:	Entries open on 1 March 2026 at 00:00 am in the morning. Entries close on 31 May 2026 at 23:59 pm in the evening. All entries, fully completed as required, must be received by the promoter(s) before 23:59 pm on the 31 May 2026. The promoter(s) reserve the right to extend the competition. Notice of this will be posted in these rules.
Winner’s announced on:	Three (3) winners will be selected on the 15 June 2026 and three (3) winners will be selected on the 15 July 2026, and the final four (4) will be selected on the 15 August 2026. Winners will be notified via an App Push Notification (APN).
