Entries open and close:	Entries open on 19 September 2026 at 00h00 Entries close on 20 September 2026 at 00h00 All entries, fully completed as required, must be received by the promoter(s) before 00h00 on the closing date. The promoter(s) reserve the right to extend the competition. Notice of this will be posted in these rules.

Winner/s announced on:	Between 6 October 2026 and 9 October 2026. Winners will be contacted telephonically.
Eligibility: Who qualifies to take part?	This competition is open to all individuals over the age of 18 who live in the Republic of South Africa and who would qualify for an RMB Private Bank account (including RMB Young Professionals). IMPORTANT – PRIVACY MATTERS

IMPORTANT – LIABILITY

You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the competition rules.
